## DISTRICT OF HIGHLANDS BYLAW NO. 382

A Bylaw to authorize the borrowing of the cost of purchasing one (1) new Single Axle, 1800-2000 Gallon Tender and for the cost to construct a new 1000 square foot post disaster built apparatus bay addition to the West Fire Hall at 1564 Millstream Road

WHEREAS it is deemed desirable and expedient to purchase a single axle 1800 to 2000 gallon tender and to construct a new 1000 square foot post disaster built apparatus bay addition to the West Fire Hall at 1564 Millstream Road to improve fire protection servicing within the District of Highlands;

AND WHEREAS the estimated cost of purchasing a single axle 1800 to 2000 gallon tender and to construct a new 1000 square foot post disaster built apparatus bay addition to the West Fire Hall at 1564 Millstream Road, including expenses incidental thereto, is approximately the sum of five hundred thousand dollars (\$500,000) of which \$500,000 is the amount of debt created by this bylaw;

NOW THEREFORE, the Council of the District of Highlands in open meeting assembled enacts as follows:

- 1. The Council is hereby empowered and authorized to undertake and carry out or cause to be carried out the purchase of Single Axle 1800-2000 Gallon Tender and the construction of the new 1000 square foot post disaster built apparatus bay addition to the West Fire Hall at 1564 Millstream Road in accordance with cost estimates and the general plans on file in the District Office, and to do all things necessary in connection therewith and without limiting the generality of the foregoing:
  - a) To borrow upon the credit of the Municipality a sum not exceeding \$500,000.
- 2. The maximum term for which debentures may be issued to secure the debt created by this bylaw is ten (10) years.
- 3. This bylaw may be cited as "District of Highlands West Fire Hall Apparatus Bay and Single Axle Tender Loan Authorization Bylaw No. 382, 2016".
